Discuss how to conceptualize complicated grief in terms of cognitive fusion, experiential avoidance and remoteness from values. Describe how to accept and adapt to any type of loss including loss of physical health, loss of relationships, loss of work, miscarriage and bereavement.
- 2. Demonstrate how to plan treatment based on individualized case conceptualizations. Demonstrate how to use values to find meaning and purpose in the face of great loss. Demonstrate how to use mindfulness-based cognitive strategies and values-guided behavioral activation strategies to help clients actively build new lives, grow and flourish. Demonstrate how to engage clients in therapy, and overcome obstacles to homework.
- 3. Describe how to help clients cope with the suicide of a loved one. Describe how to resolve complicated grief through overcoming the psychological barriers to normative grieving. Describe how to help clients defuse from cognitions.
