2. Understand the Functions of Anger, Guilt and Shame: Describe the adaptive and maladaptive roles of anger, guilt and shame in clients' emotional and interpersonal lives, and identify how these emotions may present in clinical settings.

3. Apply Core DBT Skills to Emotion Regulation: Demonstrate how to teach and coach clients in DBT emotion regulation skills to reduce intensity and reactivity of anger and shame.
