3. Utilize the therapeutic relationship to create a context of relational safeness in the therapy room as a part of CFT process.
4. Discuss the multiple self-model and intervention set in CFT.
5. Identify and embody the 12 competencies of compassion, experientially training patients in using these elements.
6. Deploy a range of specific techniques that are focused on cultivating the competencies of compassion in the therapy relationship.
7. Discuss ways to implement compassionate mind training, in the service of cultivating the competencies of compassion.
8. Utilize the "compassionate self" imagery practice in helping clients develop compassionate strengths.
9. Describe the range of CFT imagery practices.
10. Use CFT experiential methods in individual or group contexts.
