1. Conduct a comprehensive assessment to identify grief-related targets, including traumatic memories of the death, unresolved attachment wounds, or unfinished business.
2. Identify complicating factors (e.g., disenfranchised grief, multiple losses, comorbid trauma) that may influence EMDR

treatment planning.

3. Assess readiness for EMDR by evaluating the client’s attachment style, affect window of tolerance, and capacity for dual attention during grief processing.
