1. Describe the mindset shift involved in using motivational interviewing. Discuss how to use motivational interviewing in diverse circumstances, to support changes in smoking, diet, exercise, drug use and medication adherence.
2. Describe how to use questions, reflections, affirmation and summaries to both engage with patients and to promote behaviour change. Discuss how the use of listening skills can help to save time by accurately capturing how patients are feeling.
3. Discuss the importance of finer skills of MI and why they work well to help patients say for themselves why and how they might change. Examine demonstrations of how the (trying to fix the problem for the patient) so often leads to wasted effort.
