## Objectives - After Attending This Program You Should Be Able To

1. Discuss the neuroscience of trauma. Describe vicarious trauma. Apply techniques for taking a trauma history without re-traumatizing the client. Employ techniques to address emotional dysregulation. Explain hyperarousal and hyperarousal. Apply techniques to increase the zone of flexibility. Discuss how to work with flashbacks.
2. Describe the six building blocks of self-compassion. Identify barriers to self-compassion Utilize techniques to assist clients in overcoming shame. Describe "exposure" as it applies to the ACT model. Contrast and compare commonalities and differences between exposure in ACT and other models. Employ methods to assist clients in overcoming nightmares through rehearsal and re-scripting.
3. Discuss clarifying values and how to use them for motivation, inspiration and guidance. Identify methods to use values to set goals and create action plans. Utilize ACT methods to help the client to build or rebuild relationships. Apply techniques to identify barriers to forgiveness and how to overcome them. Explain how to cope with setbacks while appreciating life. Discuss building resilience for future events.
