2. Use DBT principles to increase client readiness to change and actively apply alternative coping techniques. Describe self-injury recovery processes, including the need to accept discontinuous progress and slips
3. Apply strength-based approaches, including respectful curiosity in addressing self-injury. Apply respectful curiosity to sensitive conversations with clients. Work with clients to develop distraction and harm reduction techniques for reducing self-injury frequency and severity
